An accredited coach is one who has completed all required assessments and successfully gained AFC/FFA certification. This accreditation must be current and valid. Proof of certification will be required. This coach will be issued an ID card.

Should the minimum requirements not be met the following sanctions may apply:

- Unaccredited coaches will not be allowed to enter the Technical Area and will not be issued an ID card;
- Teams that do not have suitably qualified coaches may start the season on a minus three (3) point penalty and a fine equivalent to the cost of the relevant course fee that the club can access to offset fees for their coach to attend a future coaching course.
