Clubs will be charged for the grade in which the player is registered.

## **Registration Fee Overview**

Player registrations are made up of several components, including;

- ▶ The Capital Football Registration Fee set by Capital Football.
- ▶ The Football Infrastructure Levy (FIL) set by Capital Football.
- ▶ The National Registration Fee (NRF) set by Football Federation Australia (FFA).
- ▶ The Club fee set by each Club (and as such are not listed in this circular).

## **Capital Football Player Registration Fee**

The Capital Football Player Registration Fee contributes to the preparation and delivery of football competitions and programs including the National Premier Leagues, Senior Leagues, Junior Leagues, MiniRoos, referee development, and inclusion programs (i.e. Powerchair football, Football Connect, and Cerebral Palsy and Acquired Brain Injury programs).

Costs for the National Insurance Program, incorporating the player accident support program and Club Directors and Officer Insurance are also incorporated into the Capital Football Player Registration Fee.

## **Football Infrastructure Levy (FIL)**

The FIL is a fee that contributes towards facilities development. This has included the maintenance of the Hawker Football Centre, and more recently enabled Capital Football, as a joint contributor, to unlock a significant amount of Government funding to develop a Home of Football in Throsby.

The goal for the Home of Football is to provide much needed facilities to the community and, over time, return revenue to the sport, reducing the reliance on registrations fees and providing a new source of revenue that can contribute to other facility developments.

## **National Registration Fee**

The NRF is a fee set by FFA that is levied to Member Federations on a per registered player basis. The NRF is charged at \$33 per adult and \$14 per junior player (including GST).

## **Local Club Fee**

The Local Club Fee is set by individual clubs, considering the costs they incur in delivering football. This fee typically comprises costs including;

- ▶ Training ground hire
- ▶ Match ground hire
- ▶ Referee fees
- ▶ Equipment and apparel
- ▶ Other costs associated with the individual club programs
