CHAIR'S REPORT





Saying 2020 was a year like no other is an understatement. Our community showed how resilient we are as we dealt with the challenges of bushfires and smoke, hailstorms and the COVID-19 virus and what the resulting impacts had on our daily activities.

Despite these challenges and because we are a community that pulls together, we were fortunate to still be able to have football competitions at all levels, in all forms and for all age groups, with restrictions that ensured the safety of all participants. It was the combined efforts of everyone involved in our football community including our hard-working club volunteers and players and parents that made the season a success in the trying circumstances. I also want to acknowledge and thank the Capital Football staff, who began working remotely in March and despite the scaled back operations and reduced hours from April, still went above and beyond to ensure a football season was successfully achieved.

Our Strategic Plan for 2020-23 was ready to launch just as the pandemic was surfacing, so was held back due to the uncertainty and seriousness of how the COVID-19 pandemic would change us as an organisation and indeed as a sport. The decision in March 2020 to suspend grassroots football activities was not confined to our region but was a decision made by Football Australia in consultation with all Member Federations. We were united in our resolve to assist, protect and reduce infection or transmission risks for the football and broader community.

While the Strategic Plan was not officially launched, the areas of focus and priorities guided the work and operations for Capital Football in 2020. The Board continued to instil good governance and to make decisions in the best interest of football to get us through 2020 but also to ensure we would be able to operate in future years. Our strong financial position and stewardship, together with financial assistance from the Australian and ACT Governments allowed us to continue to operate (at a reduced level) and decreased the forecast deficit.

With the 'bad' there was also 'good'. The support from the ACT Government by not charging ground hire fees in 2020 not only provided Capital Football but all member clubs with some much needed financial relief.

And while we needed to socially distance, in some respects we were more connected to each other than ever before by using technology for communicating and for meetings, including the 2020 Annual General Meeting. Our referee and coach education opportunities also increased by using technology with an increase in courses and participants.

Notwithstanding the shortened season and impacts to clubs, more than 85% of teams from 2019 participated in competitions in 2020 and we had a record breaking 170 adults sign up for Canberra Foot and Ankle Clinic (CFAC) Walking Football. I'm pleased football was able to provide a sense of normality in an otherwise uncertain time.



Capital Football has a strong record of achievement for championing women's football and women in football. History was made again with the appointment of the first all-female referee team officiate a Capital Football NPL1 Men's match. In the year where Australia was named co-host with New Zealand of the FIFA Women's World Cup 2023TM, again I'm pleased Capital Football is a leader in developing and promoting women.

The restrictions on crowd numbers resulted in more fans tuning in to watch Capital Football's NPL than ever before. With more than 125 matches broadcast, more than 2.51 million minutes of NPL footage was watched via live stream on our YouTube page, up by 64% on 2019.

Our vision is to be the most inclusive and respected sport in the region. We took further steps towards this as we launched the first dedicated football academy for people with a disability. This would not have been possible without the generosity of the Canberra community, with more than \$120,000 thanks to the hard work of Rotary and the Capital Regional Muscular Dystrophy.

It's been a big year and despite the challenges we can all be proud of what we have achieved in the year that was. On behalf of the Board, I would like to acknowledge and thank everyone who contributed to football in our region in 2020.

CEO'S REPORT





While 2020 was a challenging year for football, it was a challenge that we overcame as a community.

COVID-19 RESPONSE

Responding to the impacts that COVID-19 has had on our community, Capital Football implemented cost reduction measures to protect the financial position of the sport, including adjustments to our workforce and application to government for support packages.

Concurrently, the ACT Government announced that it would not charge ground hire fees to community sport clubs.

In June 2020, Capital Football confirmed an ability to deliver a "half season" from July to September 2020. Aligned with that, Capital Football announced a reduction by 50% to the Capital Football player and referee registration fees. In doing this, Capital Football chose to absorb the cost of preparation for the season, which commenced in October 2019, and continued throughout the temporary suspension of football as we worked to support players, coaches, referees and clubs through isolated practices, to the resumption of training and then the commencement of competitions.

The discounting of the Capital Football player and referee registration fees, waiving of fees by the ACT Government for field hire and condensed season length presented the following financial relief to clubs in Capital Football competitions;

- The discounting to the Capital Football player and referee registration fees provided financial relief of \$685K compared to the full season fees.
- The provision of ACT Community Sports Grounds at no cost for the winter season represented a saving to the football community of circa \$800K.
- The reduced season length and number of matches at which referees officiated, resulted in clubs expending \$192K less in referee match fees this winter season.
- The \$1.68M reduction in costs supported club financial positions and resulted in reduced fees to players, to promote football and ensure the game remained accessible to all.



IN THE FACE OF CHALLENGES, WE ACHIEVED SOME GREAT THINGS

Participation

Despite the impact of COVID-19, football's participation rates remained strong, with 33,604 participants in Capital Football and Canberra United programs in 2020.

The presence of COVID-19 was going to have an impact on our ability to play football and attract and retain participants given the shortened winter season. It was however extremely pleasing to see more than 14,500 people register to play in the 2020 winter competition.

Particularly pleasing is the participation of women and girls in football. While the total participation in football fell by 16%, female participation grew by 1%. This is a great base for us to build on as we seek to achieve gender parity in participation rates over the coming years.

Also pleasing to see was the increase in Summer Football participation. Clubs became more active in delivering Summer Football competitions, with 12 competitions delivered in 2020. This saw an increase in Summer Football participants by 5,171 players.

NPL Live Streaming

Even with a shortened winter football season, more fans tuned in to watch Capital Football's National Premier Leagues than ever before.

More than 125 matches broadcasted by BarTV across our National Premier League Women's and Men's 1st grade, and Men's U23 competitions.

This saw over 2.51 million minutes of National Premier Leagues footage watched via live stream on Capital Football's YouTube page during the 2020 season, up by 64% from 2019 (1.57 million minutes viewed).

Powerchair

Powerchair football is a modified version of soccer for electric wheelchair users, including persons with quadriplegia, multiple sclerosis, muscular dystrophy, cerebral palsy, hand trauma, stroke, and other spinal cord injuries.

In 2017, Capital Football and Capital Region Muscular Dystrophy joined forces to form a local Powerchair football team, with monthly training sessions and come and try days hosted twice a year. Since then, the team has grown to eight players who train once a week, using standard electric wheelchairs with modified bumpers (rather than the purpose-built strike force sports chairs).

Thanks to the generous support of Rotary and Capital Region Muscular Dystrophy, who together raised \$120,000, Canberra United's Powerchair football team received new strike force sports chairs in 2020.

The provision of the purpose-built sports chairs with ensure Canberra United's Powerchair team to compete in the Australian Powerchair Football National Championship competition, which features five Australian State teams as well as two teams from New Zealand.



THANKYOU

I want to extend a sincere thanks for everyone's efforts to deliver football in 2020.

From the time football was suspended in March, to the resumption of isolated practice, non-contact training, contact training and matches, we saw an enormous amount of effort put in by people across our game.

I would like to acknowledge the club committees who took on extra work and responsibilities communicating with their communities and preparing for and delivering a range of activities as we moved through the staged return of football. The help provided as we developed the amended competition models, refund process and preparation of COVID-Safe plans was significant and I am sure very much appreciated by the players who, because of that work, were able to get back on the park.

Our referees adapted to the interrupted preparation to the football season, engaged in online learning and trained in isolation in readiness to serve the game once it returned.

From March to July, we held an unprecedented number of meetings with our Board, Committees and Club Presidents. The extra time spent by volunteers to engage and contribute to ensure football not only survived the challenges in front of it but overcame them was amazing.

Then as we approached the season's end, all our clubs, players, referees and parents supported each other as we rescheduled matches for the Wagga City Wanderers, Yoogali SC, and Griffith FC due to the NSW Health recommendations. I would like to thank all the teams that accommodated a reschedule of their home matches to Cootamundra to ensure the teams from Wagga and Griffith were able to continue in the competitions.

This work was also reflected in our Futsal competitions, including those delivered by North Canberra Futsal. We thank all those involved in Capital Football and North Canberra Futsal competitions for their efforts to deliver competitions in a Covid safe manner.

Finally, I would like to thank and acknowledge the staff at Capital Football. They showed the utmost commitment and professionalism when we closed the office and moved to remote working, adjusted to part-time hours while football was postponed, then put in an enormous amount of effort over a short space of time to get the competitions up and running again. I am extremely proud of the work they delivered and honoured to work beside them.

HALL OF FAME INDUCTEE - ALLYSON FLYNN

Long serving referee, Allyson Flynn was inducted into the Capital Football Hall of Fame for her outstanding contribution for football in the ACT and surrounding region. Allyson has officiated at the Olympics, FIFA Women's World Cup, AFC Champions League and AFC Women's Asian Cup, and closer to home, more than 50 A-League and Westfield W-League matches.

In addition to her on-field achievements, Allyson's contribution to the development of match officials in the Canberra and surrounding region has been, and continues to be, very important to her. She has encouraged, supported, mentored, coached and advocated for referees at a local, state and national level throughout her career and beyond.

Allyson is an inspirational role model for all referees, especially women. Her achievements, commitment and dedication to her own career along with supporting and developing grassroots referees, through to her strong friendships built with her peers at a national or international is un-paramount.

Her legacy is meaningful and will influence the next generation of elite female officials for years to come.

PARTICIPATION

Football maintains its position as the largest participation sport in the ACT and surrounding region, involving 33,604 participants in 2020.

Capital Football continues to record the highest percentage of females playing football in the country, as female participation rose by 1% on 2019.

The 2020 NPL1 Men's 1st Grade competition saw a different format to previous seasons due to the shortened season. The regular season consisted of one round, with the top four and bottom four being split for Championship and Playoff series respectively. Canberra Croatia FC, Gungahlin United FC, Belconnen United FC and Tigers FC finished in the top four, qualifying for the Championship Series, whilst Tuggeranong United FC, Canberra Olympic FC, Woden Weston FC and Monaro Panthers FC competed in the Playoff Series.

Canberra Croatia FC and Gungahlin United FC finished first and second following the completion of the Championship Series Round Robin and met in the Grand Final, with Canberra Croatia FC coming away 3-1 winners, defeating the defending Champions.

The 2020 NPL2 Men's 1st Grade competition saw Yoogali SC finish in first place on the ladder with 21 points from eight matches, followed closely by Queanbeyan City FC on 18 points. Wagga City Wanderers FC and Canberra White Eagles rounded out the top four with 14 points each, Wagga City Wanderers FC claiming third spot by virtue of goal difference. Yoogali SC confirmed their spot in the Grand Final with a 3-2 extra time victory, whilst Wagga City Wanderers FC beat Queanbeyan City FC 2-1 in the other Semi Final, also in extra time. The 'all-regional' Grand Final went all the way to penalties, with Wagga City Wanderers defeating Yoogali SC 5-4 on penalties, after the teams could not be split after 120 minutes of football, finishing 2-2.

The 2020 Men's Charity Shield did not take place due to COVID-19.

Canberra Croatia FC ended the 2020 NPL Women's season sitting in first on the ladder, with 24 points courtesy of a perfect 8 wins from 8 matches. Belconnen United FC and Gungahlin United FC followed with 16 points each, with Belconnen United FC claiming second place with the greater goal difference. Canberra Olympic FC rounded out the top four, only one point behind.

Canberra Croatia FC continued their run with a 4-1 victory over Canberra Olympic FC to book their place in the Grand Final. Belconnen United FC confirmed that it would be a rematch of the 2019 Grand Final with a 4-1 victory over Gungahlin United FC in their semi final. Canberra Croatia FC rounded out a perfect season, overturning the 2019 result to defeat Belconnen United FC 2-0, winning all ten competitive matches they played in 2020.

The 2020 Women's Charity Shield did not take place due to COVID-19.





ACTEWAGL JUNIOR LEAGUE & MINIROOS

Capital Football would like to thank the ongoing support of ActewAGL for yet another season of junior football. Capital Football would also like to thank all of the Clubs, including club committees, volunteers, players and their parents for all of their hard work. The 2020 ActewAGL Junior League and MiniRoos Season was a shorter season than most. Despite this, we still had 222 teams compete across 26 competitions in the U12-U18 age groups. In the U10 and U11 MiniRoos age grades 186 teams competed across 21 competitions. Across both ActewAGL Junior League and MiniRoos Capital Football, there were a total of 13 girl's only competitions, comprising of a total of 100 teams. 2020 saw a total of 1,043 ActewAGL Junior League fixtures and 860 MiniRoos fixtures played over 190 fields, including MiniRoos fields, across the 3 months of competition.

The 2020 ActewAGL Junior League season was purely around participation due to the limited amount of footballing opportunities. The decision was made to maximise the number of rounds played by all participants. There were also no premiers awarded for the 2020 season, to further highlight the season as being about participation.

Capital Football and the competitions team would also like to extend appreciation to the Junior Standing Advisory Committee for their assistance in the multiple meetings prior to the commencement of the football season. Your feedback and assistance was highly welcomed throughout the 2020 season and we look forward to working with the committee for the 2021 season.

SENIOR LEAGUES

Capital Football would like to thank the Clubs, including club committees, volunteers and players for all of their hard work and sacrifices they may have had to make to ensure that we had a season.

The 2021 Senior Leagues Season was a short season compared to previous years. The decision was made to run all Senior Leagues competitions as participation only, to play as many games as possible whilst we had the ability to do so. Therefore, for the 2020 Senior Leagues competitions, there were no premiers, nor champions.



Across the Senior Leagues Competitions, we saw a total of 173 teams, with a breakdown in the table below:

SUMMER FOOTBALL

Summer Football was approached differently across the 2020/21 summer season, to give clubs the option to run competitions themselves.

This decision gave clubs the option to extend their seasons, while also providing them with ways to lessen financial impacts from COVID-19.

This new process saw a total of 11 clubs running a variety of competitions across the Summer Football season. The clubs that nominated to run competitions were:

Capital Football provided support to these clubs across the Summer Football season, from Play Football, SportsTG and from a disciplinary point of view, with the hopes to grow this space and provide more support and resources for clubs.

Many of the competitions ran from October through until December 2020, with some then recommencing in January following a Christmas break.







It was another big year of Capital Football's social futsal, with a total of 809 players competing in 115 teams during the 2019/20 Summer Futsal Season. Winter futsal did not run during 2020 due to COVID-19. North and South Canberra Futsal again ran junior social competitions during the 2019/20 season.

Men's and Women's Futsal Premier League ran again in 2019/20. Boomerangs FS did the double in the Men's competition, finishing as Premiers before going on to win the Grand Final and be crowned Champions. Golden Boot winner Matthew Corey scored 14 goals in just 12 games as part of a strong North Canberra Untouchables team who only lost the Grand Final, 3-2. Canberra FC did the double in the Women's Futsal Premier League, finishing as Premiers in the regular season before defeating North Canberra Untouchables 3-0 in the Grand Final. Brittany Palombi from Canberra FC took out the Women's Golden Boot award, scoring 17 goals across 12 round matches.

The Premier League competitions were also run at the end of 2020, with a downsized 6 team, 10 round competition completed on Thursday 17 December 2020. Boomerangs FS repeated their success, finishing first again before taking out the Grand Final 3-2 over Timberwolves FC. Jayde James-Ward claimed the Golden Boot with 17 goals in 10 games. North Canberra Untouchables overturned their loss in the 2019/20 Grand Final, winning the 2020 Futsal Premier League Women's Grand Final 3-2 over Canberra Croatia FC after finishing as Premiers. Brittany Palombi and Catherine Brown shared the Golden Boot, both scoring 11 goals in eight round matches.

Boomerangs FS competed in the Football NSW Futsal Premier League 1 competition in 2019/20 following promotion in the 2018/19 season. The Club was relegated after finishing bottom of the Club Championship, as none of their teams finished in the top four.

In a year that presented unique challenges, Capital Football was able to adapt and deliver a total of 85 referee activities, which included: referee courses and education, training and development sessions. A total of 1766 people attended the activities throughout the year.

The number of new football match officials increased by 12% in 2020, with the total number of female match officials increasing by 18%. This represents 23% of the total football match officials, compared to 19% in 2019.

In 2020 the number of Game Leaders increased by 43%. Game Leaders now account for 39% of the total registered football match officials.

There was an increase (11%) in registered futsal match officials for the 2019/20 futsal season, with female match officials now accounting for 11% of total registered futsal match officials, compared to less than 1% in 2018/19.

The retention rate of futsal match officials increased from 51% (2018/19) to 58% (2019/20), while the retention rate of football match officials has remained at 45% for the third consecutive year.

REFEREE DEVELOPMENT FOOTBALL

The most important date of the year is the Preseason Seminar. This is the only day in which Capital Football endeavours to get all the referees together in preparation for the season ahead.

For the first time, the 2020 seminar was a full day event (9am to 5pm) with the highest participation rate seen in recent years. The seminar was opened by the Chair of the Board of Directors and presentations were provided by Matthew Cheeseman (Football Australia Referee Manager), an expert psychologist on mental resilience, and a sports chaplain.

In 2020 for the first time, educations sessions were scheduled twice per month and female only education sessions were introduced into the Referees Calendar.

With the impact of COVID-19 and the suspension of football activities, education sessions continued as scheduled using video conferencing with additional sessions introduced in July in the lead up to the resumption of competitions.

The use of video conferencing for delivery meant that sessions were able to be recorded. This enabled referees who were unable to attend, to view the session later, as well as giving people the opportunity to revisit and review session content.

Referees, like players, need a degree of physical fitness to be able to cope with the demands of the game as well as prevent injury. Providing opportunities for referees to work on their physical fitness is important for the game as well as the longevity of the referees. As such weekly training sessions were delivered, as was pre-season fitness testing.



Notwithstanding the impact of extreme heat, smoke, COVID-19, the suspension of football activities, wet weather and issues with venues, more training sessions were delivered in 2020 than were scheduled for the entirety of 2019.

FUTSAL

A preseason seminar for Futsal Premier League (FPL) and senior competitions was held and for the first time was a full day event. The seminar followed a similar purpose to the football pre-season seminar: to prepare referees for the season ahead and attain consistency in refereeing throughout the season.

Like football referee sessions, futsal referee education sessions were held using video conferencing facilities. Sessions were held in October and early November and topics from the preseason seminar were revised and results of video / Laws tests were reviewed.

REFLIVE

Capital Football partnered with sports technology company RefLIVE in 2020 to monitor the wellbeing of match officials and track team behaviour across football and futsal competitions.

The RefLIVE smartphone app allows referees to complete a post-match analysis of their match experience, the behaviour of the teams they officiated and a selfassessment of their own performance.

RefLIVE provided Capital Football with insights into the referee's experience on a week-to-week basis. Importantly, RefLIVE enabled Capital Football to provide support to referees within 48 hours who experience extreme abuse from players, team officials or spectators during a match.

SUCCESS STORIES

In his third year officiating in the Foxtel Y-League, Nathan Shakespear was the Referee for the Foxtel Y-League Grand Final between Sydney FC and Melbourne Victory.

Referee Georgia Ghirardello and assistant referees Lauren Hargrave and Delfina Dimoski made Capital Football history, becoming the first all-female referee team to officiate a Capital Football NPL1 Men's match.

Owen Goldrick, Greg Taylor and Adam Powers were reappointed to the A-League Assistant Referee panel for the 2020/21 season, and Richard Naumovski was also reappointed as an A-League Assistant Video Referee.



Lauren Hargrave and Delfina Dimoski were reappointed to the Westfield W-League Assistant Referee panel, with Georgia Ghirardello also retaining her position on the Westfield W-League Referee panel.

Clive Mackillop continues to represent Capital Football at a national level with his reappointment to the national Referee Assessor panel.

FEMALE FOOTBALL WEEK

In 2020, Capital Football endeavoured to extend Female Football Week, by asking clubs to run programs throughout the year.

Brindabella Blues Football Club successfully ran a Female Football girls only program in March, where the current female players invited a female friend to come and try football. It was a huge success with more than 30 females participating.

As part of the national Female Football Week awards, Capital Football coach Kelly Stirton was named Female Community Coach of the Year, recognised for her work in being a female coach within the footballing community.

FOOTBALL CONNECT CANBERRA UNITED ALL ABILITY ACADEMY

The Canberra United All Ability Academy is the first dedicated football academy for people with a disability in the ACT. The Academy is believed to be the first all ability academy aligned with either an A-League or Westfield W-League club and is open to all footballers with cerebral palsy, acquired brain injury or symptoms acquired from a stroke.

The academy was launched nationally on 7 September 2020, with 19 players joining the academy. The players trained two nights per week (Monday and Friday), at Hawker Football Centre.

CANBERRA UNITED POWERCHAIR FOOTBALL TEAM

Canberra United held a Development Weekend with the New South Wales (NSW) Development Powerchair Team as well as a few of the Victoria players in early March. During the weekend, the teams went through skill sessions and practice games. The teams took place in skill sessions and practice games throughout the weekend, culminating in the inaugural Rotary Cup match between Canberra United Powerchair and the NSW Development Powerchair team. Canberra United took out the close match 1-0.

Since 2017, the team has grown to eight players who train once a week, using generic electric wheelchairs with homemade modified bumpers.

To help the team reach their full potential, Capital Football approached Rotary to ask for their assistance to raise over \$120,000 for nine new Powerchairs to be bought from the United States.

In October 2020, the Canberra United Powerchair Football team received a new set of wheels, thanks to the generous efforts of Rotary, Capital Region Muscular Dystrophy and the Canberra community.

ALL-ABILITY LEAGUE

2020 saw the All-Ability League players focus on increasing their skillset, under coaches Merryn Brown and Jason Driscoll. Players of all abilities trained together in an 8-week program, allowing 25 players to join in skills sessions every Saturday morning at Hawker Football Centre.



SKILL ACQUISITION PROGRAM

The 2020 Skill Acquisition Program (SAP) encompassed six age groups in both boys and girls: U7, U8, U9, U10, U11 and U12.

These groups were part of a training environment which was designed to supplement the club-based training and games of each player by providing additional training contacts during the week.

A user-friendly registration model was implemented in 2020 allowing players to register for just one term or all four and choosing their preferred training night (Monday and/or Friday). More than 100 young players were involved in the 2020 SAP season.

The SAP coaches used a mix of traditional skills training delivery methods and newly introduced Game-Intervention-Game (GIG) methodology.

The program was conducted by qualified coaches (minimum C-Licence).

The Head Skill Acquisition Trainer was Phil Booth, who for the past 22 years has specialised in the skill acquisition phase of development.

Throughout 2020, all of the coaches who delivered the SAP program went through weekly design and self/group evaluations for the purpose of personal and professional development.

The SAP program ran from February through to early December.



TALENT SUPPORT PROGRAM





The Capital Football TSP continued in 2020, allowing players to attend the supplementary training in addition to their club training and matches throughout the year.

TSP consisted of three groups across the U13, U14 and U15 age groups, training twice per week (Monday and Wednesday).

TSP focussed on skill acquisition and game training throughout the year, which aligns with Football Australia's Talent Identification guidelines.

The TSP Coaches maintained contact with all players during the COVID-19 lockdown via Zoom meetings and our various Slack channels. Activities included:

- Monday-Wednesday-Friday challenges
- One-on-one online meetings with players
- A Zoom meeting with former Socceroo Luke Wilkshire
- A Zoom meeting with Football Australia Technical Director and National U17 coach Trevor Morgan.

Tobias Peil and Noah Steinacker were invited to participate in a Football Australia Elite Game in New South Wales at the start of the season.

There were similar games planned throughout the season, that were subsequently cancelled due to COVID-19.

The Canberra United Academy (CUA) season was somewhat disrupted due to Covid-19 and the change in Head Coach at the start of the National Premier League Women's (NPLW) season. Capital Football Technical Director, Scott O'Donell took over the First team duties until Vicki Linton was appointed and took up her role as Head Coach of Canberra United (CU) and CUA towards the end of the NPLW season.

Like we do before the start of every season, we held an 'Information Night', to explain to our players and parents the expectations for the season ahead.

All training sessions for CUA were held at Hawker Football Centre. This made things easy in terms of the movement of players between squads. The CUA players were made aware at the start of the season that players will be selected in the respective teams based on their performances throughout the season in training sessions and in games.

There were regular meetings between coaches to decide on the make-up of the squads each week.

PERFORMANCE MANAGER

Caleb Smith was appointed as the Performance Programs Manager, which allowed the CUA Senior Squads to receive regular GPS reports for both coaches and players.

This was beneficial in both educating players in how to benchmark their performances using the data collected as well as providing national team coaches with data to compare players in the CUA program to others from around the country.

INJURY CLINIC

Sarah Kelly (CU and CUA Physiotherapist) conducted an injury clinic every Thursday, to diagnose and treat our injured players.

Physiotherapists or Sports Trainers were present at all training sessions and games throughout the season.

PLAYERS REVIEWS

Player reviews took place at the conclusion of the season. All coaches sat down with their players, to go through their Individual Development Plans, which included identifying areas of improvement, setting goals and preparing for the 2021 season.

COMMUNICATION VIA SLACK

Communication through Slack allowed a platform for information to be shared instantly, also allowing opportunity for different groups to be added.

CLUB COACH COORDINATOR



The Club Coach Coordinator role was introduced in 2020 to assist clubs in providing support for their NPL Youth and NPLW coaches.

In addition to providing individual support for coaches, the Club Coach Coordinator also helped coaches prepare periodised training plans, session plans, and conducted model sessions throughout the season.

The Club Coach Coordinator was also available to observe and provide feedback to coaches with their training sessions and match day management.

Responsibilities of the Club Coach Coordinator include:

- Supporting the NPLY and NPLW Coaches
- Monitoring and mentoring club coaches and providing support based on their individual needs.
- Assisting coaches to develop and review their coaching and reflecting on their behaviours.
- Ensuring the coaches have access to appropriate learning opportunities and resources including websites, courses, and workshops.
- Creating a positive, safe and non-threatening environment in which players and coaches feel that they can try new things, make mistakes and learn.

In addition to the CCC program, Capital Football also engaged with female coaches via a Mentoring Program, which involved monthly group meetings with the respective coaches. The Mentoring Programs included individual and group meetings about behaviour management, communications skills, leadership and career planning.

COACH EDUCATION



In 2020, online courses and workshops took the lead with Community Coaching Courses being adapted to online learning modules and the first ever online Football Australia B-Licence. This allowed courses to be delivered to more than 150 coaches throughout the year.

COMMUNITY COACHING COURSES

A total of 13 community courses were delivered throughout 2020 via online learning and face-to-face contact in the ACT region, ranging from the MiniRoos Certificate up to the Skill Training Certificate. The Community Coaching portfolio courses are based around helping new coaches attain education and experience as they begin their coaching journey.

The MiniRoos Certificate is for coaches who are working with players between the ages of 5 and 9 in the Discovery Phase of the National Coaching Curriculum. This area of the curriculum focuses on developing the coach's skills to enable them to create a fun football environment for MiniRoos aged players.

The Skills Training Certificate (STC) is aimed at coaches who work with the 9-13 age bracket, who are in the Skills Training Phase of the Curriculum. The focus of a coach in this phase is on the development and delivery of the four core skills: passing/ striking the ball, first touch, running with the ball and 'one vs one' situations. A number of clubs hosted STC coaching courses, and a total 40 coaches received their STC qualification as a result.

ADVANCED COACH EDUCATION

The implementation of the NPL/NPLW and NPLY minimum coaching accreditation saw an increase in demand and need for advanced courses in the region. Having more qualified coaches will help clubs ensure their coaching staff are suitably qualified and accredited to oversee teams in 2021 and beyond. As seen in the table below, 95 coaches attended Advanced Coaching courses in 2020.

In addition to the advanced courses, the Capital Football Performance Department conducted multiple online coach education workshops from 'Manual Match Analysis' to 'Managing Unlimited Substitutions'.

Each workshop was worth 10 points towards the advanced coach's re-accreditation.

With the lack of face-to-face time due to Covid-19, the number of online sessions increased with the inception of 'From the Sidelines' a new online interactive workshop. Guest speakers ranged from Football Australia Technical Director Trevor Morgan to our own panel of advanced female coaches.

A total of nine 'From the Sideline' sessions were delivered covering a multitude of relevant topics from 'Goalkeeper training methods' to 'Returning to football non-contact session design'.

Capital Football would like to thank all guests for their expertise and taking the time to deliver these beneficial workshops.

Capital Football was able to deliver the only face-to-face State Coaching Conference last year, which was attended by 45 local coaches. Our guest speakers included: Giovani Fernandes (Senior Manager Coaching Development Department- FIFA), Trevor Morgan (Football Australia National Technical Director), and Kevin Grima (Football Australia Boys Youth Development Manager).



CANBERRA UNITED





The 2019/20 season saw Canberra United compete in Season 12 of the Westfield W-League and in the Foxtel Y-League for the third time.

WESTFIELD W-LEAGUE

TABLE OF FINANCIAL POSITION

Capital Football ended the 2020 financial year with an operating deficit of -\$206K and a net asset position of \$3.54M.

This outcome was influenced by;

- The Covid-19 Pandemic that saw football suspended from March to June 2020, resulting in;
 - ▶ 19% decrease in winter football registrations.
 - No delivery of the Kanga Cup.
 - No delivery of National competitions including the National Youth Championships, National Training Centre Challenge, and Foxtel National Youth League.
 - Reduced delivery of referee and coach education courses.
- Delivery by Capital Football of a "half" winter season from the time football activities could resume (July 2020) through to the end of the winter season access to fields (September 2020).
- Decision by Capital Football to provide a 50% refund of registration fees to winter football players in 2020, aligned to the half season competition delivery.
- Decision by FFA to reduce Member Federation Funding.
- Capital Football staff being placed on reduced hours during the temporary suspension of football.
- Receipt of \$484K in Covid-19 stimulus from Government, including, \$384K Jobkeeper subsidy, \$100K ATO cash flow boost and \$36K ACT Government sports sector support.

Capital Football acknowledges the substantial support provided by the Federal and ACT Governments in response to the Covid-29 pandemic. This support included cash grants, the Jobkeeper initiative that enabled us to retain our workforce, and the waiving of sports ground hire fees. Without this support, football would not have been resourced to remain active and engaged during 2020, nor capable of resuming football activities once it was safe to do so.

Principal Activities

The principal activities of the Federation during the financial year included administering and developing the code of football.

Operating Results

The deficit of the Federation for the year amounted to \$205,819 (2019 surplus: \$189,986).

Review of Operations

A review of operations of the Federation during the financial year indicated that there had been changes to operations during the financial year due to the impacts of the COVID-19 pandemic.

In March 2020 Football Australia temporarily suspended all football activities in response to COVID-19. Concurrently, Australian Governments issued public health orders limiting physical interaction. These things combined resulted in a reduced winter football season. Football Australia also reviewed its funding of Member Federations, which was historically a part return of the National Registration fee to support delivery of programs to promote and develop football. These factors combined in a significant reduction in revenue for Capital Football. In response, Capital Football staff were placed on reduced hours from April to June 2020, returning to full time hours when the football season recommenced in July 2020.

Government stimulus initiatives supported Capital Football's operation in 2020, notably the JobKeeper program.

Significant Changes in State of Affairs

No significant changes in the Federation's state of affairs during the financial year.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2020

NOTE 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is for ACT Football Federation Limited as an individual entity, incorporated and domiciled in the Australian Capital Territory. The Federation is a company limited by guarantee.

Basis of Preparation

The financial report is a general-purpose financial report that has been prepared in accordance with Australian Accounting Standards-Reduced Disclosure Requirements, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the *Corporations Act 2001*.

Australian Accounting Standards-Reduced Disclosure Requirements set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Compliance with Australian Accounting Standards-Reduced Disclosure Requirements ensures that the financial statements and notes also comply with International Financial Reporting Standards. Material accounting policies adopted in the preparation of this financial report are presented below. They have been consistently applied unless otherwise stated.

The financial report has been prepared on an accruals basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Accounting Policies

(a) Revenue

Revenue recognised under AASB 15 is measured at the amount which the Federation expects to receive in consideration for satisfying performance obligations to a customer. A performance obligation is the distinct good or service defined within the contract with a customer. The transaction price is allocated to one or more performance obligations contained within the contract, with revenue being recognised as or when the performance obligation is satisfied.

While the Federation acknowledges the contributions made by volunteers in its continued operations, the difficulty and significant cost associated with trying to reliably measure these contributions means that the Federation has elected not to record these amounts in its financial statements.

Timing of Revenue Recognition

Revenue is recognised either at a point in time or over time, when (or as) the entity satisfies performance obligations by transferring the promised goods or services to its customers.

NOTE 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

(a) Revenue (Continued)

If the entity satisfies a performance obligation before it receives the consideration, the entity recognises either a contract asset or a receivable in its statement of financial position, depending on whether something other than the passage of time is required before the consideration is due.

All revenue is stated net of the amount of goods and services tax (GST).

(b) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other shortterm highly liquid investments with original maturities of three months or less, and bank overdrafts.

(c) Inventories

Inventories consist of football equipment and promotional materials which are measured at the lower of cost and net realisable value.

(d) Property, Plant and Equipment

Each class of plant and equipment is carried at cost or fair values as indicated, less, where applicable, any accumulated depreciation and impairment losses.

Plant and Equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by the directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have been discounted to present values in determining recoverable amounts.

Plant and equipment that have been contributed at no cost, or for nominal cost are valued at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets is depreciated on a declining-balance method basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over either the unexpired period of the lease or the estimated useful lives of the improvements, whichever best reflects the expected utilisation of the asset.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2020

NOTE 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

Asset classes carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

(e) Impairment of Assets

At each reporting date, the Federation reviews the carrying values of its tangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the Income Statement.

Where future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of an asset class, the Federation estimates the recoverable amount of the cash-generating unit to which the class of asset belongs.

(f) Employee Benefits

Provision is made for the Federation's liability for employee benefits arising from services rendered by employees to the reporting date. Employee benefits expected to be settled within one year together with benefits arising from wages, salaries and annual leave which may be settled after one year, have been measured at the amounts expected to be paid when the liability is settled. Other employee benefits payable later than one year have been measured at the net present value.

Contributions are made by the Federation to an employee's superannuation fund and are charged as expenses when incurred.

(g) Provisions

Provisions are recognised when the Federation has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the income statement. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

(h) Leases

Leases of fixed assets, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the entity are classified as finance leases.

Finance leases are capitalised, recording an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual values.

Leased assets are depreciated on a diminishing-balance basis over their estimated useful lives where it is likely that the entity will obtain ownership of the asset. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

(i) Financial Instruments

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the Federation commits itself to either purchase or sell the asset (i.e. trade date accounting is adopted).

Financial instruments are initially measured at fair value plus transactions costs except where the instrument is classified 'at fair value through profit or loss' in which case transaction costs are expensed to profit or loss immediately.

Classification and subsequent measurement

Finance instruments are subsequently measured at either fair value, amortised cost using the effective interest rate method or cost. *Fair value* represents the amount for which an asset could be exchanged or a liability settled, between knowledgeable, willing parties. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2020

NOTE 1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Amortised cost is calculated as:

- the amount at which the financial asset or financial liability is measured at initial recognition;
- ii. less principal repayments;
- iii. plus or minus the cumulative amortisation of the difference, if any, between the amount initially recognised and the maturity amount calculated using the *effective interest method*; and
- iv. less any reduction for impairment.

The *effective interest method* is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying value with a consequential recognition of an income or expense in profit or loss.

(i) Financial assets at fair value through profit or loss

Financial assets are classified at 'fair value through profit or loss' when they are held for trading for the purpose of short-term profit taking, or where they are derivatives not held for hedging purposes, or when they are designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Such assets are subsequently measured at fair value with changes in carrying value being included in profit or loss.

(ii) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost.

(iii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the entity's intention to hold these investments to maturity.

(iv) Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that are either not capable of being classified into other categories of financial assets due to their nature, or they are designated as such by management. They comprise investments in the equity of other entities where there is neither a fixed maturity nor fixed or determinable payments.

(v) Financial liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of noncash assets or liabilities assumed, is recognised in profit or loss.

(i) Taxation

No provision for income tax has been raised as the Federation is exempt from income tax under Section 50.45 of the Income Tax Assessment Act 1997.

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense.

Receivables and payables in the Statement of financial position are shown inclusive of GST. Cash flows are presented in the Statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(j) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

(k) Critical accounting estimates and judgements

The directors evaluate estimates and judgements incorporated in to the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the company.

Key estimates - Impairment

The Federation assesses impairment at each reporting date by evaluating conditions specific to the Federation that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Fair value less costs to sell or current replacement cost calculations performed in assessing recoverable amounts incorporate a number of key estimates.
