KEY TASKS

<u>Task</u>	Action Required by Club	
Trial/Training Sanction Form	 All clubs are asked to submit their trial/training information to Capital Football for sanctioning, via the Post Season Trial / Training Sanctioning Form. Trials/training sessions must be sanctioned, for participants to be covered by insurance. 	
Regulations and Competitions Structure	The 2025 JL & MR Competitions Calendar has been communicated.	
Club Affiliation Form	 We ask that all clubs please complete the <u>2025 Club Affiliation Form</u> by COB Monday 3 February. 	
Registration Package Set Up/Registration Windows	 As noted above, Registration Package Set Up has commenced. The registration window opens in January and will close Friday 30 June. If clubs require Play Football training, please let us know at your earliest convenience so we can assist. 	
Nominations in Dribl	 Clubs are asked to complete their Team Nominations through Dribl, using the guide provided, which can also be found on the <u>Dribl for Competition Management</u> page on the CF website. We ask that this task is completed by 11 March to ensure time for fixturing. If you don't think that your club is able to meet this deadline, please let us know as early as possible so that we will be able to work with you. Clubs can label their team as they wish (using numbers or a team name). 	
Team Lists	 Clubs are required to have players mapped into Dribl prior to 19 April 2025'. Clubs are to update Capital Football when players are to be added/removed from team lists. 	
Team Allocation Process	 Upon receiving the preliminary allocations from CF, we ask you to look through and provide feedback regarding any teams have been missed off the document, or if teams may have accidentally been put in a wrong division. For further information, please see below for further information 	
Age Exemptions	 Clubs are asked if they could please have all their age exemptions requested through the <u>Age Exemption Request Form</u> by Monday 30 June to ensure that all players are processed prior to the registration closes. 	
Trial Matches	 Clubs are required to complete the <u>Trial Match Request Form</u> for any inter club trial matches (i.e. trial matches that are against another club), played either against other CF clubs or other Member Federation clubs. The form should be completed by the home club, except where you are playing another Member Federation club (CF club must complete this form). This form must be submitted a minimum of seven (7) days prior to the trial match being held (please note this has been altered from previous seasons where it was five business days). 	
Pre-season Meeting	The JL & MR pre-season meeting will be held in March, with the date TBC.	















	 We ask that where possible, all Clubs send at least one (1) representative per team and any relevant Club Officials. More information will become available in the new year.
Allocations Period	 Allocated sportsgrounds, once granted to a sport are protected from the 1st of February – 30th April. As of the 1st of May, any unbooked grounds become available to anyone to hire. It is important that all clubs are aware that an allocation does not constitute and an actual ground, it is simply a reservation. Hirers are required to submit an online booking to secure their allocations. The booking system will open to accept winter 2025 bookings, midday 1st February 2025.
