Task	Action Required by Club
Trial/Training Sanction Form	<ul style="list-style-type: none"> All clubs are asked to submit their trial/training information to Capital Football for sanctioning, via the Pre Season Trial & Training Sanctioning (jotform.com). Trials/training sessions must be sanctioned, for participants to be covered by insurance.
Club Affiliation Form	<ul style="list-style-type: none"> We ask that all Clubs please complete by COB Friday 3 February. Only Clubs who have submitted this Club Affiliation Form will be able to commence registering through Play Football on the registration opening dates
Competitions Calendar	<ul style="list-style-type: none"> The 2025 Competitions Calendar has been communicated to all clubs and is publicly available on the CF website.
Registration Package Set Up	<ul style="list-style-type: none"> Registration Packages are now able to be set up in Play Football. Packages must be approved by CF prior to any Clubs commencing registrations to ensure they are set up correctly.
Nomination Form	<ul style="list-style-type: none"> Clubs are asked to complete their Team Nominations through Dribl, using the guide provided, which can also be found on the Dribl for Competition Management page on the CF website. We ask that this task is completed by 02 March 2025 to ensure there's enough time for fixturing. If your Club is unable to meet this deadline, please let us know as early as possible so can work with you. Clubs can label their team as they wish (using numbers or a team name).
Pre-season Meeting	<ul style="list-style-type: none"> The SL pre-season meeting will be held on Monday March 24.
Team Lists	<ul style="list-style-type: none"> Clubs are required to have all players mapped into Dribl prior to 24 March 2025. Clubs are to update Capital Football when players are to be added/removed from team lists.
Preliminary and Final Team Allocations	<ul style="list-style-type: none"> Capital Football will release Preliminary Team Allocations on 4 March 2024. Club Feedback will be taken as required and adjusted where possible till 6th March 2025. Final Allocations will be released on Tuesday, 11 March 2025.
Trial Matches	<ul style="list-style-type: none"> Clubs are required to complete the Trial Match Request Form for any inter club trial matches (i.e. trial matches that are against another club), played either against other CF clubs or other Member Federation clubs.

	<ul style="list-style-type: none"> The form should be completed by the home club, except where you are playing another Member Federation club (as the CF club must complete this form). This form must be submitted a minimum of seven (7) days prior to the trial match being held (please note this has been altered from previous seasons where it was five business days to ensure referee coverage can be provided).
Aus Cup/Fed Cup	<ul style="list-style-type: none"> Information for team nominations will be released prior to the Christmas break.
Allocations Period	<ul style="list-style-type: none"> Allocated sportsgrounds, once granted to a sport are protected from the 1st of February – 30th April. As of the 1st of May, any unbooked grounds become available to anyone to hire. It is important that all clubs are aware that an allocation does not constitute an actual ground, it is simply a reservation. Hirers are required to submit an online booking to secure their allocations. The booking system will open to accept winter 2025 bookings, midday 1st February 2025.
