Chair & CEO Report

Another year of football in Canberra and the surrounding region saw yet more positive growth for our game across the board and some spectacular action on the field as we crowned our League Champions, Cup winners, and Grand Final winners from junior leagues through to our flagship senior competitions.

Participation levels were up by 7% again across the board in 2024 with over 31,500 participants playing football, with a 4% growth in our male space, and a huge 15% increase in women's & girls participants with close to 10,000 females now taking part in organised football in our region.

Locally, we again extend our congratulations to the winners of all our competitions from the National Premier League and Australia Cup Qualifying through to our grassroots junior clubs, and our wonderful MiniRoos players. Our football community is the lifeblood of the game in Canberra and the surrounding region and the incredible work that our Club volunteers put in week-in, and week-out, is a testament to their dedication to our amazing game.

We were treated to seeing O'Connor Knights play A-League opposition in the shape of Macarthur FC at GIO Stadium in the Australia Cup Round of 32 and enjoyed a wonderful occasion in front of a big crowd where the Knights led before bowing out 1-2 to the team that went on to claim the trophy. The Knights were great ambassadors for our game in the region and can be proud of the show they put on.

On behalf of the Board and Capital Football we would like to thank all the businesses that supported one of our member clubs in 2024, and many of whom we hope to see return again for the 2025 season.

We also, of course, thank our tremendous Capital Football sponsors, ACT Government, ISC, Capital Chemist, the Hellenic Club, Rex Hotel, OPC, Pila, St. John Ambulance, and Performance Travel. Their support is vital to the continued success of our Federation.

Canberra United finished eleventh out of twelve in the 2023/24 Liberty A-League season but saw Michelle Heyman scoop the Golden Boot award for a third time in her career. At the end of the season, we battled hard to secure the future of the club and thanks to the support of the ACT Government we were able to announce that we would field a team in the 2024/25 A-League season with Antoni Jagarinec promoted

from Assistant Coach to Head Coach in place of Njegosh Popovich. We thank Njegosh for his service to the club across the last three seasons.

We would like to acknowledge our 2023/24 Canberra United sponsors, our Principal Partner, The University of Canberra, our Major Partners, Blumers Personal Injury Lawyers, Club Lime, ISC Sport, ACT Government, Midnight Hotel, and Gift of Life.

A thank you to our Official Support Partners, Recovery Lab, Performance Edge Physiotherapy, Hit 104.7, 10+ SCA, Canberry Cars, Belconnen Soccer Club, ACTAS and GMD. And finally, our Business United Squad Members who were Alliance ICT, Hyperscalers, Local Peoples, OPC IT, Precision Numbers, Claire Naidu & Co, Capital Recruit, Gow Gates, Liquor Legends, Canberra Dental Care, and Even Playing Fields.

The increasing professionalisation of the A-League Women's competition continues to place significant pressure on Capital Football's ability to operate Canberra United. The financial investment, time, and resources required to run a team at this elite level are growing rapidly.

Balancing these demands alongside our core responsibilities as a Member Federation—delivering community, grassroots, and development football across the ACT—has become increasingly challenging. Coupled with the ongoing uncertainty around the Canberra United Men's A-League bid, the long term future of Canberra United remains unclear.

The indoor game grew again in 2024 as our Capital Futsal League (CFL) continued for a third season, although we acknowledge there were difficulties in running the competition this season. We thank our sponsors Xela Constructions, Precinct, and BarTV for their generous support in covering the broadcast costs to allow us to stream these games to a receptive and engrossed audience.

The third year of the CFL was received very warmly by the futsal community, culminating in four excellent Grand Finals at Daramalan College and the second playing of our Futsal Charity Shield in memory of referee Cameron Shelton. We hope to continue to build on this achievement to make it a sustainable success going forward.

The culmination of the 2024 edition of the Kanga Cup took place at Southwell Park in Lyneham in the first week of July as thirty-five Grand Finals were played,

deciding the fate of the silverware following a week of intense competitive action played on grounds across Canberra and Jerrabomberra. As ever, Grand Final day threw up plenty of memorable moments and action aplenty, as games were decided by individual brilliance, wonderful team ethic, and in some cases, by who held their nerve the best in the dreaded penalty shoot-out.

355 teams participated in 2024, with nearly 70% of those being from interstate and we were pleased to be able to play some matches at the new Jerrabomberra Sporting Complex throughout the week. The conglomeration of venues at the site making for an excellent tournament experience for some of our older age groups.

The economic benefit survey ran upon the completion of the Kanga Cup showed a total direct in-scope expenditure for the ACT of \$4.1 million. A huge amount of money being brought into the region during what is usually a quiet time of the year, showcasing the continued importance of the tournament to the ACT economy.

Our Technical team launched a new talent development program, called TDS, aligning with Football Australia's pathway, it aims to provide local footballers the opportunity to improve their skills through dedicated skill acquisition sessions. The team also delivered several Coach Education courses across the year aimed at building capacity and confidence among community coaches—empowering them to contribute more effectively to their clubs and the broader football community.

In 2024, the Referee team returned to Capital Football management. We extend our thanks to Football Australia for their support over the past two years, but the time has come for Capital Football to take the reins once again.

Like many parts of the football ecosystem, match officiating has experienced significant turnover in recent years. With the Referee team now back under our direct management, we are focused on stabilising and strengthening this vital area of the game. Our goal is to improve recruitment and retention across all levels of officiating—indoor and outdoor—to ensure we can continue to deliver quality competitions. There is still much work to be done, and we remain committed to finding new ways to support, develop, and grow our community of match officials.

Capital Football officials again took to the national stage with aplomb, Owen Goldrick and Lauren Hargrave retained their positions in the FIFA International list of Assistant Referees, whilst Owen, Adam Powers, and Greg Taylor retained their positions

on the A-League Men's panel of Assistant Referees. Nathan Shakespear secured a spot on the A-League Men's Official panel making his centre debut during the 2024/25 A-League season.

The continued appointments of Georgia Ghirardello, Lauren Hargrave, and Delfina Shakespear to the A-League Women's panel, the latter having been appointed for her 100th A-Leagues Women's match in November 2024, highlighted the continued high-performance levels of our top-line match officials.

The heart and soul of our sport continues to be the volunteers, who we can't thank enough for the time and tireless commitment they make to support the teams, clubs, and Capital Football to help deliver football to the thousands of participants in the largest participation sport in Canberra and the surrounding region.

At a governance level, Capital Football welcomed a new Chief Executive Officer, Samantha Farrow, who commenced in the role following the resignation of Ivan Slavich at the end of the 2023 season. Following a thorough recruitment process, Samantha was appointed to lead the organisation through its next phase of growth and to ensure continued financial stability and operational excellence. Alongside this leadership change, Capital Football continues to strengthen internally and expand the services we offer our stakeholders.

To the Capital Football Zone Councils, Standing Advisory Committee members and Capital Football staff, thank you for your dedicated and continued commitment to football in the region.

We saw some changes in the Board for 2024, Steve Rohan-Jones was elected at the AGM as a Director, alongside the returning Frank Cachia, whilst later in the year both Frank and Andrew MacFarlane stepped down from their positions on the Board. We thank both Frank and Andrew for their service to Capital Football and the game during their time on the Capital Football Board.

As ever running a Member Federation isn't without its challenges, but we are confident that we are heading in the right direction, rebuilding our relationships with stakeholders, as we continue to help foster and grow an exciting suite of products that are well-received by our ever-expanding participation base.

Participation

Participation levels continued to be strong in the region during the 2024 season with overall growth in our outdoor game once more rising by 7%. There was an impressive rise in the number of female participants within our overall outdoor football space with numbers standing just short of 10,000, an increase of 15%. Whilst growth in the number of male participants wasn't as high, it was still pleasing to see an uplift of 4% on the 2023 figures.

We celebrated successes for Belconnen United, Canberra Olympic, and Gungahlin United in the Women's leagues, whilst there was silverware for Canberra Croatia, O'Connor Knights, Gungahlin United, Queanbeyan City, and ANU FC in the men's. Our NPL and Junior League finals saw Majura FC, Tuggeranong United, Woden Valley, Wagga City Wanderers and Brindabella Blues adding their names to the clubs who won a trophy in the finals series.



Charity Shields

Youth Girls

Belconnen United 4 (Murphy 17', Wells 35', Rodda 42', Shea 48')
West Canberra Wanderers 0

Belconnen United were crowned as the inaugural Youth Girls Charity Shield winners with a convincing 4-0 victory over **West Canberra Wanderers** at Deakin Stadium on a sunny Sunday morning in Canberra. The Blue Devils struck first with a superbly taken goal by Isla Murphy, her shot flashing past Wanderers custodian Iva Spelic to open the scoring.

Wanderers recovered well, but it was the team in Sky Blue who were dominating territory and possession, and it was little surprise when they doubled their lead five minutes before the interval of the forty-minute halves. The industrious Scarlett Wells took a pass into her stride and, settling in front of goal, drove a firm effort beyond the reach of Spelic who had no chance with a crisply taken strike. Belconnen effectively took the match away from the Wanderers with a brace of goals within minutes of each other at the commencement of the second-half. Eden Rodda was in the right place at the right time to add the third, before Samantha Shea guided home a header from close range.



Youth Boys

Canberra Croatia 1 (Lulic 70')
Canberra Olympic 1 (Mustafa 80')
– after extra-time, Canberra Croatia win 5-4 on penalties

Canberra Croatia claimed the inaugural Men's U18 Charity Shield defeating **Canberra Olympic** 5-4 in a penalty shoot-out following a dramatic conclusion to the eighty-minute match when Olympic levelled at 1-1 with the last kick of the encounter. Goalscoring opportunities were at a premium on a warm day, neither goalkeeper particularly troubled in the opening forty-five minutes, Croatia going closest with a pair of strikes from range which flashed past Olympic stopper Vanna McAlister's woodwork. The second-half continued in the same vein; a midfield battle being evenly contested with nothing between the sides. Croatia finally broke the stubborn Olympic resilience with a fine goal netted ten minutes from time when Xandy Lulic volleyed home left-footed from the edge of the six-yard box following a pin-point cross from the right flank, the finish flashing high into the top right corner of Joshua Smith's net. Olympic though weren't to be denied however and stole a leveller with the last kick of the match. A free-kick dropped into the Croatia box and was scrambled over the line by Qais Mustafa sending the contest into a penalty shoot-out where Croatia prevailed.



Women

Canberra Olympic 2 (Cachia 21', Brown 78')
Belconnen United 1 (Bobbin 15')

Canberra Olympic secured the Women's Charity Shield, their first success in this format, with a late Ella Brown winner guiding them to a narrow 2-1 success over **Belconnen United** in front of a large crowd at Deakin Stadium. Brown was introduced into the fray off the substitutes bench in the 55th minute and, 23 minutes later, was perfectly positioned to latch onto an Ali Cook free-kick to send a thumping volley beyond the reach of debutant Blue Devils goalkeeper Monique Pinkiewicz who had no chance of stopping it. It was the Blue Devils who drew first blood after quarter-of-an-hour thanks to sensational work from forward Reilly Yuen. Yuen backtracked to just outside the Belconnen penalty area to tidy up a through ball and advanced before rapping a perfect pass into Keira Bobbin up front. There was still plenty to do for Bobbin whose first touch took the ball away from the covering Katrina Peric and allowed the speedster to advance clear on goal where an unerring finish, low beyond the advancing Janet King, who was well-beaten by the accurate finish. Olympic responded well and were level within six minutes with a wonderful goal. Bessie Riethmuller played a part, laying off a flick with a perfectly weighted touch, which allowed Madison Cachia, operating at the top of the midfield diamond, to lash a low shot into the back of the net.



Men

O'Connor Knights 2 (Adams 5' (p), Ihegie 62')
Canberra Croatia 0

Goals in each half from Micheal Adams and Aisosa Ihegie gave League Champions **O'Connor Knights** their first-ever Charity Shield success as they defeated neighbours, and derby rivals, **Canberra Croatia**, 2-0 at Deakin Stadium. In front of a large and noisy crowd, the Knights were clinical with their opportunities, striking from their limited chances, and showing real championship pedigree to hold off Croatia who were left shaking their heads at the number of gilt-edged chances that they passed up on a warm Sunday afternoon, a number inside the opening five minutes. By that stage, the Knights were already ahead from the penalty spot. Ihegie showed his power, turning young defender Parris Bangweni inside the area and drawing a foul for a cast-iron spot-kick. Adams made no mistake from the resultant penalty, coolly sending Jason Matesa the wrong way. Atiya Waraga missed a glorious opportunity to equalise just before the hour when he lost his marker to meet a Thomas James cross that drew Seb Arranz out of position, the usually lethal front-runner tamely heading over from inside the six-yard box. And the Knights made them pay by doubling their lead within moments. Daniel Roberts played a pass to Jackson Paesler who clipped a well-weighted ball over the flat Croatia defence. The bounce invited Ihegie to meet it, and the forward showed his bravery, being clattered by Matesa, but crucially getting the definitive touch to nod home.

Canberra Croatia 4 (Barac 45+3', 90+4' (p), Colbertaldo 63', 108')
Tigers FC 3 (McGregor 13', Taneski 45+2', Bailey 53') – after extra time

The NPL Men's competition saw eight teams competing in the top tier for the 2024 season following the promotion of Yoogali SC. **Gungahlin**

United emerged as worthy Champions after an epic 21-round battle, claiming the League Championship on the final day, confirming their title with a 4-2 win over Tigers FC to win the crown by three points. The Gunners were joined in the finals by **Canberra Croatia**, **O'Connor Knights**, and **Tigers FC**. **Canberra Olympic** were relegated and will be replaced in the 2025 competition by CPL Champions **Queanbeyan City**. Lukman Ahmed-Shaibu of **Gungahlin United** claimed the Golden Boot with seventeen goals.

Canberra Croatia claimed back-to-back Capital Football NPL Grand Final crowns with a sensational win by the odd-goal in seven against **Tigers FC** in a showdown for the ages at Deakin Stadium. A brace from substitute Daniel Colbertaldo, and a double from Daniel Barac securing a dramatic 4-3 victory. Tigers appeared on course for victory as they led 2-0 and 3-1 through goals from Archie McGregor, Hristjan Tanoski and a cracker from Angus Bailey, but Croatia have been in such tight spots before and they stunned Tigers with a leveller from the penalty spot deep into stoppage time and won it in extra time as Colbertaldo stabbed home the winner.

Canberra Croatia 2 (Learmonth 14', Majetic 87')
Gungahlin United 2 (D'Addario 41' (p), Thomson 70' (p)) – after extra time.
Canberra Croatia won 4-2 on penalties.
Player of the Match: Ivica Majetic (Canberra Croatia)

The Men's under-23 league title was won by **Canberra Croatia** with fifty points, five points clear of second-placed **Gungahlin United**. The rest of the finals series was made up of **Tigers FC** and **O'Connor Knights**. **Canberra Croatia** emerged as champions in the Grand Final defeating **Gungahlin United** in a thrilling penalty shootout at Deakin Stadium after the pair shared four goals in a pulsating 2-2 draw after extra-time. Owen Learmonth had Croatia in front, but a brace of penalties from Gungahlin had them in front before Ivica Majetic equalised with three minutes remaining, ultimately setting up the penalty shoot-out from which Croatia triumphed.



NPL Women

The NPL Women's competition saw seven teams competing in the top tier for the 2024 prizes, and **Canberra Olympic** were to emerge triumphant as



they claimed the League Championship crown by four points from **Belconnen United**. Both teams qualified for the finals series, where they were joined by **Gungahlin United** and **Canberra Croatia**. At the foot of the table were Tuggeranong United, but there was no relegation with the 2025 competition seeing the addition of **Majura FC** to complete an eight-team league. Alyssa Di-Campoli of **Belconnen United** won the Golden Boot with seventeen goals.

Canberra Olympic won a third consecutive Grand Final against **Belconnen United**, thanks to a dominating first-half during which the two goals were scored. Trophyless before 2022, the O'Connor outfit is now hanging some silverware in their cabinet for the sixth time. Player of the match Nicole Jalocha's thumping left footed effort eight minutes before the break summed up the first half well. Taken with her first touch, the missile from outside the box found the top left corner with so much power it could have ripped through the net. That added to the opener turned in from close range by Tianah Miro.

Belconnen United 3 (Roberts 23', J. Emms 55', Altamore 86')

Belconnen United were crowned Women's National Premier League Reserves League champions by winning the title by two points ahead of **Gungahlin United**. They were joined in the Finals series by **Canberra Olympic** and **Canberra Croatia**. Doubles from centre-forward Sophie Burns and substitute Juliana Stauffacher helped **Gungahlin United** claim victory in the Women's National Premier League Reserves Grand Final against **Belconnen United**, the Gunners claiming the silverware in a seven-goal thriller.

CPL Men

Queanbeyan City finally realised their dream of a place in the NPL with a dominating display in claiming the CPL crown, finishing ahead of **ANU FC** by two points, the final table perhaps not indicative of their success.

Belconnen United ended third with **Brindabella Blues** also making the finals. Niko Abot of **Queanbeyan City** top-scored with 21 goals. **Queanbeyan City** added the CPL Grand Final silverware to their League Championship crown with a 2-0 victory over a gallant **Brindabella Blues** at Riverside Stadium, thanks to a goal in each half netted by midfield maestro Dejan Santrac and ace goal-poacher Nico Abot.

Belconnen United were the top dogs in the CPL U23 competition finishing three points clear of **ANU FC** at the top of the table in what was an exhilarating title race. Third place went to **Canberra Juventus**, who would ultimately make the Grand Final, and **Brindabella Blues** ended fourth making up the teams for the finals.

The match proved a step too far for a gallant Juventus side who had shown in the lead-up to the Final that they had the quality necessary by defeating the League Champions **Belconnen United** twice on their way to reaching the Grand Final showdown but were unable to replicate that on the big day.

Federation Cup Final

Belconnen United 1 (Tein 9')
Canberra Croatia 0

An early Pearl Tein goal was enough for **Belconnen United** to retain their Federation Cup title against **Canberra Croatia** at Deakin Stadium, the Blue Devils winning the Cup Final by a solitary goal to nil. The best attack and best defence in the NPLW this season showed off the latter on their archrivals' turf, whilst the heroics of the Blue Devils' back three were further highlighted by the Player of the Match award going to Bronte Pyke. Scott Conlon's players start on the front foot, smothering Canberra Croatia in their own half for the first five minutes. The answer for the "home" team came from a series of set pieces, but the eventual outcome would be Belconnen's goal.



Games sometimes are decided by details. The third consecutive corner kick for Canberra Croatia was cleared away by Reilly Yuen, for what should have been another corner, yet a goal kick was given to Monique Pinkiewicz. Six passes later, the winning goal was in the back of the net. The lightning speed attack saw the ball going from Pinkiewicz to Tein, via Maddy Steinacker, Pyke, Lauren Preston and Pascale La Hei in nineteen seconds. The midfielder, waiting for La Hei's cut back pass at the edge of the box, finished with a precise first touch in the bottom left corner, leaving Ellie Summers no chance.

The **O'Connor Knights** recorded their first Federation Cup Final triumph for sixteen years, and secured a place in the Round of 32, as they defeated **Monaro Panthers** 4-2 in an exciting Australia Cup Qualifying Final at Deakin Stadium. Central defender Lachlan Fields was the official Man of the Match, but it was the story of the past three years for the Knights in that it was the collective that saw the O'Connor club across the line, with performances of top calibre everywhere you looked amongst the men in the checked shirts. As Roko Strika was forced to watch the Final from his sickbed, his replacement in the starting eleven, Jenno Ceruti, struck twice, the first to equalise from close range after excellent approach work by lithe winger Ben Basser-Silk. By then, the Knights had hit the front, the first of their quartet of goals. Jackson Paesler had put O'Connor ahead after twenty-four minutes.

The inspirational Micheal Adams made the second, as he glided past a couple of challenges two minutes into time added on and released Patrick O'Rourke, the midfielder keeping his head to score a similar goal to Paesler, albeit from the other side of the field. What really opened the match in favour of the Knights though was the third goal netted four minutes after the resumption. Goalkeeper Seb Arranz found Aisosa Ihegie and the forward rolled his marker and rounded Quinn to net. There would be a fourth goal, and it was one that was down to the sheer quality of Fields. The rampaging defender collected a loose pass from Luca Macor halfway inside his own half before waltzing upfield on a fifty-metre run, drifting past Basser-Silk, Zac McLaren, Ryan Straub, and Dylan Deep-Jones, before feeding Paesler who advanced to clinically slot home his second of the evening.

Capital Football Awards

Tigers FC midfielder Tomohiro Ogawa was crowned as the Capital Football Men's National Premier League Player of the Year at the Capital Football Annual Awards Night held at the Rex Hotel in Braddon, whilst the Women's award was jointly shared by Canberra Olympic duo Jaya Bowman and Madelyn Whittall. The awards reflected the trio's part in their team's successful season, Ogawa a shining beacon in the heart of the Tigers FC team that ended the season strongly to reach the Grand Final, Bowman and Whittall integral parts of the almost all-conquering Olympic outfit that won the League Championship, Grand Final, and Charity Shield.

Queanbeyan City's Argentinean lynchpin, Nahuel Guerrero, stormed to the title of Capital Premier League Player of the Season, capping an impressive year for City who achieved promotion to the top tier and claimed Grand Final glory at Riverside Stadium.

Elsewhere, Yoogali FC stalwart Sante Donadel was awarded the Volunteer of Year, whilst South Canberra collected the Club of the Year gong. Tuggeranong United scooped the new Award for Innovative Program of the Year, providing opportunities for players to engage with areas and topics that are not related to their pure football ability.

Capital Football also welcomed two new recruits into their Hall of Fame with local legends Andy Bernal and Amy Duggan recognised and honoured for their parts in promoting the region through their respective, and storied, football careers, two very worthy recipients.

In the Coach's Awards, Cristal King of Belconnen United CPL U23 was named Coach of the Year after her side had won the League Championship, whilst Blue Devil Scott Conlon was named as the NPLW Coach of the Year. His Canberra Croatia counterpart Dean Ugrinic claimed the NPLM version of this Award.

There was double delight for Nathan Shakespear in the Referee Awards category, the whistleblower winning the NPLM Referee of the Year, and overall Referee of the Year Awards with newcomer Lauren Riddel

being rewarded for an excellent debut season with the NPLW Referee of the Year trophy. Capital Football congratulates all of its winners.

Junior Leagues & Miniroos

The 2024 Junior League and MiniRoos season was one to remember for community Football, seeing significant growth in team and participant numbers off the back of the Women's World Cup, including an increase of 26 Junior League Girls and MiniRoos teams from 2023.

In 2024, the Junior League and MiniRoos seasons were reduced in from an 18-round season in 2023 to a 16-round season. The decision to reduce the Junior League and MiniRoos season was made after ongoing consultation with the Football community, the Junior Advisory Standing Committee (JSAC) the Capital Football Competitions Department, and the Capital Football Board of Directors.

The season commenced on Saturday 4th April, with 284 Junior teams across twenty-eight competitions in the U12 – U18 age groups, an increase of 42 teams from 2023.

The MiniRoos competitions also saw an increase in team numbers, with 239 teams in 2024. An increase of 41 teams from 2023, across sixteen competitions in the U10-U11 age groups.

Such growth in the number of teams entered in the Junior League and MiniRoos competitions was pleasing, however, brought to light the significant need for further investment and access to facilities for clubs in the ACT and surrounding regions.

The MiniRoos concluded the regular season on Saturday 7th September, meanwhile the Junior League Opens and Girls season concluded on Saturday 14th September, with all Grand Finals being held at Calwell Playing Fields. A big congratulations to all of the Champions, Runners-Up Premiers, and Players of the Match.

Capital Football extends our thanks to all of the clubs, volunteers, parents, participants, and the standing advisory committee for their efforts and support throughout the 2024 season. We look forward to another year of growth and enjoyment in 2025.

Capital Futsal League

The 2024 Capital Futsal League season was consolidated into an 11-week block with the competition finals taking place on 13-15 December at Daramalan College. Bringing the competition prior to Christmas allowed the CFL free space, meaning there would be no New Year clash with the National Futsal Championship, or the early start of the outdoor pre-season campaign for our clubs.

We had a full ten round competition in 2024 where matches were played at our CFL location of Daramalan College (Daramalan Dome), the Australian Institute of Sport, Canberra Futsal Centre in Fadden, and the Queanbeyan Indoor Sports Centre. Competitions were held for First Grade men and women, plus a Reserve Grade competition for women and an under-23 competition for men.

All six clubs, ANU Apex, North Canberra Fire, Queanbeyan-Palerang Power, South Canberra Swift, UC Stars and West Canberra Lightning returned for the new season with all clubs fielding teams in both grades across men and women, with 24 teams in total across the four age grade competitions.

Whilst there were some scheduling difficulties through the season, the action was top-class and threw up plenty of highlights as even more CFL records were broken across the board.

Capital Football extends its thanks to all who were able to make these competitions possible with a special mention to our three Broadcast sponsors, without whom there would have been no streaming coverage of the league in 2024. With the financial backing of Xela Construction (principal Sponsor) alongside Precinct and BarTV, we were able to stream a minimum of four of the six matches each round, with all six fixtures covered on four occasions throughout the season. We also broadcast all four Grand Finals live on Sunday 15 December 2024.

Senior Futsal Leagues

The 2024 futsal season presented challenges in securing venues but demonstrated resilience and potential across senior and junior competitions. Capital Football is grateful for the continued participation and support from players, teams, and families throughout the year.

The **Senior Winter Futsal League** ran from late April to early September. The Women's League featured six teams in one competition, the Men's League hosted 43 teams across seven competitions, and the Mixed League included six teams in one competition, delivering another exciting season of futsal.

The **Senior Summer Futsal League** began in mid-October and will run through to March 2025, with interest from 120 teams. The Women's League hosted 10 teams in two competitions, the Men's League had 38 teams in five competitions, and the Mixed League included six teams in one competition. Efforts to establish a new shortened senior league competition in early November saw minimal interest but highlighted opportunities for future development.

Junior Futsal League

The **Junior Capital Futsal League** ran from mid-October to late December, featuring 50 teams in nine competitions for boys and girls aged U11 to U17. This league provided a structured and competitive environment for junior players.

The **Junior Futsal League** attracted significant interest from 166 teams. From mid-October to late December, 119 teams competed across 14 competitions for boys and girls from U6/7 to U18. After gaining access to additional venues, a new shortened summer competition was introduced in early November for U10/11, U13/14, and U18 open age groups, hosting 20 teams across three competitions.

National Futsal Championship

A spectacular week in Melbourne saw ten Capital Football teams take on their peers from around Australia in the 2025 National Futsal Championship. There were amazing individual performances, outstanding team displays and plenty of goals.

Our goalkeepers were excellent, our defensive displays rock solid, our creativity sublime, and our finishing top notch. At the end of the Grand Finals, we also had a National Champion in our **Open Women's – Blue**, with the team going undefeated the entire tournament and defeating NSW Thunder in the Grand Final thanks to a goal from Stella De Marco.

Two ACT players won the Golden Shoe being **Mounir Jbieli** (U12 Boys – 12 Goals) and **Brittany Palombi** (Open Women 11 – Goals). **Jbieli** was also awarded the MVP award for the U12 Boys, adjudged to be the best player in the competition. Our Open Women's Head coach **Van Nguyen** was awarded Coach of the Tournament in that grade.

Referees

Capital Football Referees have experienced success in education, development, high performance, and pathways. This report highlights the achievements and progress made during this period, underscoring our commitment to excellence and the promising future ahead. It also identifies a national trend of declining referee numbers, despite the continued growth of new referees through courses.

Registrations

Football Referees: In 2024, a total of 394 football referees registered, a slight decrease from the 396 in 2023. This drop was offset by the addition of 161 new referees, alongside 233 returning officials from the previous year. Additionally, 295 Game Leaders were registered in 2024, further strengthening the officiating community.

Futsal Referees: The futsal refereeing community saw a decline in 2024, particularly in the junior ranks, with a total of 79 registered referees, down from 112 in 2023. This cohort included 16 new futsal referees, along with 63 returning officials from the previous year.

Overall, while football referee registrations remained steady, the influx of new referees and the strong presence of returning officials highlight the resilience of the officiating community.



Education and Development

We successfully conducted six Junior Match Official (Level 4) Referee courses, benefiting 182 students. Furthermore, 30 referees upgraded their qualifications within the referee pathway, showcasing a commitment to continuous improvement. The year also saw 22 new Futsal Referees and seven new Referee Coaches completing their training. Our commitment to supporting clubs was evident through the presentation of Game Leader courses across the region, aimed at fostering leadership skills among referees.



High Performance

Owen Goldrick and Lauren Hargrave retained their positions on the FIFA International list of Assistant Referees, underlining their exceptional skills. Maintaining high standards, Goldrick and Adam Powers retained their positions on the A-League Men's panel as Assistant Referees. Greg Taylor made the decision to retire from the A-Leagues' Match Officials Panel. Declan Woods secured a spot on the A-League Men's 4th Official panel for the first time, while Nathan Shakespeare retained his position on the panel. In November, Shakespeare made his debut as a Centre Referee on the A-League Men's fixture between Central Coast Mariners and Perth Glory in Gosford.

We were pleased to see the reappointment of Georgia Ghirardello, Hargrave, and Delfina Shakespeare to the A-League Women's panels, reflecting their consistent high performance. In April, Ghirardello, reached a significant milestone, officiating her 50th match as a Centre Referee on the A-League Women's panel. In November, Shakespeare officiated her 100th A-League Women's match, becoming the second Assistant Referee on the ALW panel and the first woman from Canberra to achieve this remarkable milestone.

Additionally, the 2024 A-League awards introduced a new category: the 'Best Up-and-Coming Referee Award'. This accolade celebrates young officials showing immense potential. The inaugural recipient, Lachlan Li Chiang from Canberra, Australia, has made a remarkable impression. At just 16 years old, Lachlan officiated at the Italy World Games (for participants between 9 and 19 years of age) and IberCup Barcelona, where he was recognised as the "Talent of the Tournament" at both events, solidifying his bright future in officiating.

Retirements

Greg Taylor has called time on a refereeing career spanning the best part of two decades. Starting as a junior referee at Tuggeranong, he progressed through Capital Football's Referee Academy, representing Canberra in multiple National Youth Championships and achieving an appointment to the National Youth League in 2009. The 2013-14 season saw him promoted to the A-League Assistant Referee Panel to mark start of an eleven-year career at the highest level of the game in Australia. His debut came in November 2013 in a fixture between the Central Coast Mariners and Brisbane Roar alongside fellow Canberrans Ben Williams and Allyson Flynn. After 82 matches in the A-League as an Assistant Referee including multiple finals series games, Greg made the decision to hang up his boots/flags last season (2023/24) in the round 27 clash between Melbourne Victory and Brisbane Roar. Capital Football wishes to congratulate Greg Taylor on an excellent career at the highest level and thank him for the significant contribution he has made to football and refereeing in the region.

Pathways

Once again, Capital Football Referees had the opportunity to attend the National Youth Championship (under 15s and under 16s boys and girls) events in July, held in Wollongong (boys)

and Melbourne (girls), highlighting the talent and dedication of our young referees. Harrison Cracknell and Jordan King represented Capital Football at the boys' tournament, while Vince Cosentini and Lauren Riddel attended the girls' tournament. Game Development

The Nationals were held in Queensland from August 26 to August 31 and the team played six matches, with two wins, two draws, and two losses. All-abilities

Talent Development Scheme (TDS)

The 2024 TDS program was a new development following Football Australia's (FA) restructuring of the talent development pathways. 11-Week TDS

With the introduction of the new Foundation of Football, Futsal and Goalkeeping courses, Capital Football were pleased to offer a wide variety of opportunities for coaches to gain new qualification or upskill their qualifications during 2024.

Foundation of Football Course

- From 5 courses, a total of 84 participants went through and completed the course.

Foundation of Futsal Course

- From 1 course, a total of twelve participants went through and completed the course.

Foundation of goalkeeping Course

- From 2 courses, a total of eighteen participants went through and completed the course.

Advanced Coaching Courses (AFC/FA C-Diploma and B-Diploma)

C-Diploma

- Three C-Diploma courses were conducted throughout the year.
- A total of 49 participants went through the C-Diploma in 2024 which included the pre-requisite of the Foundation of Football Course.
- Eight of the participants were female.

B-Diploma

- Capital Football completed one B-Diploma course in 2024 and commenced a new course.
- A total of 19 participants participated in the B-Diploma in 2024.
- Three of the participants were female.

State Coaching Conference

The State Coaching Conference was held on Saturday 7 December at the Australian Institute of Sport with fifty spots available. Presented by Capital Football Technical Director Phil Booth, plus Kelly Stirton and Josh Waugh, the Conference saw five hours allocated to all attendees against their Continuous Personal Development (CPD).

Featuring World champion ParaMatildas Head Coach Kelly Stirton reviewing the successful World Cup campaign, and Canberra United Head Sports Analyst Josh Waugh, presenting around the usage of modern-day GPS in sport, the Conference also looked ahead with future planning.

Canberra United

Season Review

Canberra United's 16th Liberty A-League Women season, led by Head Coach Njegosh Popovich, was one of rebuilding and regeneration. The club finished in 11th place out of 12 - the lowest in its A-League history - with six wins, six draws, and ten losses, totaling 24 points. This placed United nine points clear of bottom side Adelaide United and nine adrift of the finals cut-off.

Despite the ladder position, attacking football remained a hallmark of the side, with United netting 39 goals — the fourth-highest tally in the league and just one less than champions Melbourne City. Defensively, however, the team struggled, conceding 47 goals, with only Adelaide faring worse (56).

Star striker Michelle Heyman continued her legacy, claiming the Liberty A-League Golden Boot for the third time with 17 goals from 22 appearances. Her performance earned her a deserved recall to the Matildas.

The season also marked a significant investment in youth, with 12 players making their Canberra United debuts. The average squad age was just 22.6, and 14 players were aged 21 or younger. Several of these young talents gained national recognition: Chloe Lincoln, Sasha Grove, and Tegan Bertolissio were selected for the Young Matildas squad that finished third at the AFC U20 Women's Asian Cup, with Sofia Christopherson and Mary Stanic-Floody named in the extended group. Ruby Nathan also made her senior international debut for New Zealand.

A disrupted pre-season due to registration delays impacted preparation, with the squad assembled late and limited match-ready opportunities early

on. This early challenge was evident in game management, with several late goals conceded across the season. However, the team finished strongly, with two clean sheets and three wins from the final three games — their best defensive stretch of the year, marked by high defensive duel success, improved aerial contests, and increased tackle attempts.

Off the pitch, the club enjoyed unprecedented engagement. Membership reached a record 983, driven by post-World Cup momentum and strong marketing campaigns. Match attendances were consistently strong, peaking at 2,229 in Round 4 against Perth Glory and averaging close to 1,500 — with only one fixture falling below 1,000.

While the results didn't match aspirations, the foundations laid in 2023/24 — both on and off the field — have set the stage for growth and resurgence in Season 17.

Principal Activities

The principal activities of the Federation during the financial year included administering and developing the code of football in Canberra and the Capital Region.

Review of operations

The Federation reported a total comprehensive surplus for the financial year of \$91,076 (2023 deficit: \$350,162).

This result reflects the continued financial impact of Capital Football operating Canberra United, our A-League Women's team. The reporting period incorporates the latter part of the 2023-24 season and the early stages of the 2024-25 season.

As previously noted, Capital Football remains the only Member Federation to manage its own A-League side. While we have successfully operated Canberra United since 2008, the increasing cost of running a professional team continues to place pressure on the organisation's financial position. The expansion of the A-League Women's competition has contributed to this, with the season now comprising 23 matches, up from 12 games in 2020-21 and 14 in 2021-22.

In March 2023, the Australian Professional Leagues (APL) announced plans to introduce a men's team to partner with Canberra United as part of its broader expansion strategy. However, no franchise was awarded in time for season 2024-25.

In response, Capital Football worked proactively to secure additional financial support from the ACT Government, ensuring Canberra United's continued participation through the 2024-25 season. We are sincerely grateful to the ACT Government for their continued support. This support is critical to maintaining our commitment to elite women's football in the region as we await further clarity from the APL regarding expansion and the long-term sustainability of the league.

Save CU, now known as Canberra Women's Football Inc., have raised funds to contribute directly to the costs of Canberra United operations for the second half of their season. The group will be expected to meet this commitment with funds to be received in the 2025 financial year.

Excluding Canberra United, the remainder of the organisation delivered a net surplus, underlining the strength and stability of our core operations.

Football participation continues to thrive in the ACT. In 2024, overall participation grew by 7%, with more than 31,500 people playing football across the region. Notably, we recorded a 4% increase in male participants and a remarkable 15% growth in women's and girls' participation, with nearly 10,000 females now playing organised football in our region.

The Capital Futsal League (CFL) continued into its third season, and we remain focused on building a more sustainable model for the competition.

In late 2024, management of match officials returned to Capital Football after being administered by Football Australia for the past two years. Match officiating has experienced significant turnover in recent seasons, and we are committed to stabilising and strengthening this vital part of the game.

The Kanga Cup remains a key event on the football calendar, with 355 teams and around 5,000 participants taking part during the July school holidays. This year's tournament welcomed teams from across Australia—including NSW, Victoria, Tasmania and WA—as well as international teams from New Zealand.

The post-event economic benefit survey revealed a total direct in-scope expenditure of \$4.1 million in the ACT, reinforcing the tournament's importance to the local economy during a typically quiet period of the year.

Significant Changes in State of Affairs

No significant changes in the Federation's state of affairs during the financial year.

After Balance Date Events

Discussions remain ongoing between the APL and interested parties regarding the awarding of a new A-League Men's franchise or a standalone Women's franchise in Canberra. In the absence of certainty around the establishment of a new team, Capital Football continues to explore alternate funding models to enable Canberra United's participation in Season 18. Capital Football has made it clear that it can no longer underwrite the financial losses of the team.

At the time of reporting, no other matters or circumstances have arisen since the end of the financial year that have significantly affected, or may significantly affect, the operations of the Federation, the results of those operations, or the state of affairs of the Federation in future financial years.

Short and long-term objectives

The Federation's long-term objective is expressed in its stated purpose to provide high quality experiences for everyone involved in football in all its forms; with the associated vision for the Federation to be the most inclusive and respected sport in Canberra and the Capital Region.

Key short term strategic objectives include achieving improvements and growth in the following areas of operation:

- Participation – at all levels (e.g., age, gender) and across all forms (e.g., 11 a-side, Futsal).
- Talented & Elite – including participant numbers and team results (e.g., TSP, Canberra Utd).
- Fans – including attending and streaming games, along with increased digital footprint.
- Governance – including commercial growth, and financial sustainability.

The strategies for achieving these objectives are framed by the following Constitutional Objects:

- FA membership & compliance.
- FA & Member collaboration.
- Governance, administration, regulation and protection of Football.
- Fostering friendly player & official relations.

Game Development programs in Powerchair, All-Abilities and Walking Football continue to be well attended despite the challenges Capital football has faced with appointing a regular coach for these programs. There were 31,500 participants in Capital Football programs during 2024, this is an increase of 7% from 2022. The biggest increases were experienced in junior competitions including Minirooms, social players and Community Leagues coaches and officials.
- Educate and Enhance – Representative teams competed at the Futsal Nationals, Powerchair Nationals and National Youth Championships. The total number of referees saw a small increase with 81 additional registrations compared to 2023.
- Thrive and Prosper – Capital Football acknowledges all our very generous corporate partners as their ongoing support ensures we continue to support our community.





NOTE 1. MATERIAL ACCOUNTING POLICY INFORMATION

The financial report is for ACT Football Federation Limited as an individual entity, incorporated and domiciled in the Australian Capital Territory. The Federation is a company limited by guarantee.

Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards - Simplified Disclosures, Interpretations of the Australian Accounting Standards Board and the *Corporations Act 2001*.

The financial statements are presented in Australian dollars which is the Federation's functional and presentation currency. The amounts presented in the financial statements have been rounded to the nearest dollar.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

A number of new or revised Australian Accounting Standards are effective for the first time in the current financial year.

These standards have had no material impact on the entity.

The following is a summary of the material accounting policies adopted by the Federation in the preparation of the financial statements. The accounting policies have been consistently applied, unless otherwise stated.

Accounting Policies

(a) Revenue

Revenue recognised under AASB 15 is measured at the amount which the Federation expects to receive in consideration for satisfying performance obligations to a customer. A performance obligation is the distinct good or service defined within the contract with a customer. The transaction price is allocated to one or more performance obligations contained within the contract, with revenue being recognised as or when the performance obligation is satisfied.

(a) Revenue (Continued)

While the Federation acknowledges the contributions made by volunteers in its continued operations, the difficulty and significant cost associated with trying to reliably measure these contributions means that the Federation has elected not to record these amounts in its financial statements.

Timing of Revenue Recognition

Revenue is recognised either at a point in time or over time, when (or as) the entity satisfies performance obligations by transferring the promised goods or services to its customers.

If the entity satisfies a performance obligation before it receives the consideration, the entity recognises either a contract asset or a receivable in its statement of financial position, depending on whether something other than the passage of time is required before the consideration is due.

Plant and Equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by the directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have been discounted to present values in determining recoverable amounts.

Plant and equipment that have been contributed at no cost, or for nominal cost are valued at the fair value of the asset at the date it is acquired.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised lease assets is depreciated on a declining-balance method basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over either the unexpired period of the lease or the estimated useful lives of the improvements, whichever best reflects the expected utilisation of the asset.

The depreciation rates used for each class of depreciable assets are:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

Asset classes carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposal of assets are determined by comparing the proceeds on sale with the carrying amount of the asset. These gains or losses are included in the income statement. When a revalued asset is sold, amounts previously credited to the Asset Revaluation Reserve relating to that asset are transferred to Retained Earnings.

(e) Impairment of Assets

At each reporting date, the Federation reviews the carrying values of its tangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the Income Statement.

Where future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of an asset class, the Federation estimates the recoverable amount of the cash-generating unit to which the class of asset belongs.

(f) Employee Benefits

Provision is made for the Federation's liability for employee benefits arising from services rendered by employees to the reporting date. Employee benefits expected to be settled within one year together with benefits arising from wages, salaries and annual leave which may be settled after one year, have been measured at the amounts expected to be paid when the liability is settled. Other employee benefits payable later than one year have been measured at the net present value.

Contributions are made by the Federation to an employee's superannuation fund and are charged as expenses when incurred.

(g) Provisions

Provisions are recognised when the Federation has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(h) Leases

Leases of fixed assets, where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership, are transferred to the entity are classified as finance leases.

Finance leases are capitalised, recording an asset and a liability equal to the present value of the minimum lease payments, including any guaranteed residual values.

Leased assets are depreciated on a diminishing-balance basis over their estimated useful lives where it is likely that the entity will obtain ownership of the asset. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

(i) Financial Instruments

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the Federation commits itself to either purchase or sell the asset (i.e., trade date accounting is adopted).

Financial instruments are initially measured at fair value plus transactions costs except where the instrument is classified 'at fair value through profit or loss' in which case transaction costs are expensed to profit or loss immediately.

Classification and subsequent measurement

Finance instruments are subsequently measured at either fair value, amortised cost using the effective interest rate method or cost. *Fair value* represents the amount for which an asset could be exchanged or a liability settled, between knowledgeable, willing parties. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Amortised cost is calculated as:

- i. the amount at which the financial asset or financial liability is measured at initial recognition;
- ii. less principal repayments;
- iii. plus or minus the cumulative amortisation of the difference, if any, between the amount initially recognised and the maturity amount calculated using the *effective interest method*; and
- iv. less any reduction for impairment.

The *effective interest method* is used to allocate interest income or interest expense over the relevant period and is equivalent to the rate that exactly discounts estimated future cash payments or receipts (including fees, transaction costs and other premiums or discounts) through the expected life (or when this cannot be reliably predicted, the contractual term) of the financial instrument to the net carrying amount of the financial asset or financial liability. Revisions to expected future net cash flows will necessitate an adjustment to the carrying value with a consequential recognition of an income or expense in profit or loss.

(i) *Financial assets at fair value through profit or loss*

Financial assets are classified at 'fair value through profit or loss' when they are held for trading for the purpose of short-term profit taking, or where they are derivatives not held for hedging purposes, or when they are designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Such assets are subsequently measured at fair value with changes in carrying value being included in profit or loss.

(ii) *Loans and receivables*

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost.

(iii) *Held-to-maturity investments*

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the entity's intention to hold these investments to maturity.

(iv) *Available-for-sale financial assets*

Available-for-sale financial assets are non-derivative financial assets that are either not capable of being classified into other categories of financial assets due to their nature, or they are designated as such by management. They comprise investments in the equity of other entities where there is neither a fixed maturity nor fixed or determinable payments.

(v) Financial liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expires, or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability, which is extinguished or transferred to another party and the fair value of consideration paid, including the transfer of noncash assets or liabilities assumed, is recognised in profit or loss.

(j) Taxation

No provision for income tax has been raised as the Federation is exempt from income tax under Section 50.45 of the *Income Tax Assessment Act 1997*.

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense.

Receivables and payables in the Statement of financial position are shown inclusive of GST. Cash flows are presented in the Statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

(k) Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

(l) Critical accounting estimates and judgements

The directors evaluate estimates and judgements incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the company.

Key estimates – Impairment

The Federation assesses impairment at each reporting date by evaluating conditions specific to the Federation that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined. Fair value less costs to sell or current replacement cost calculations performed in assessing recoverable amounts incorporate a number of key estimates.

I also:

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the ACT Football Federation Limited's internal controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by ACT Football Federation Limited.
- Conclude on the appropriateness of ACT Football Federation Limited' use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on ACT Football Federation Limited's ability to continue as a going concern. If I conclude that a material uncertainty exists, I am required to draw attention in my auditor's report to the related disclosures in the financial report or, if such disclosures are inadequate, to modify my opinion. My conclusions are based on the audit evidence obtained up to the date of my auditor's report. However, future events or conditions may cause ACT Football Federation Limited to cease to continue as a going concern.

- Evaluate the overall presentation, structure and content of the financial report, including the disclosures, and whether the financial report represents the underlying transactions and events in a manner that achieves fair presentation.

I communicate with ACT Football Federation Limited regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including when considered necessary any significant deficiencies in internal control that I identify during my audit.
