Task	Action Required by Club
Trial/Training Sanction Form	<ul style="list-style-type: none">All clubs are asked to submit their trial/training information to Capital Football for sanctioning, via the Post Season Trial / Training Sanctioning Form.Trials/training sessions must be sanctioned, for participants to be covered by insurance.
Regulations and Competitions Structure	<ul style="list-style-type: none">The 2026 Competitions Calendar has been communicated.
Club Affiliation Form	<ul style="list-style-type: none">We ask that all Clubs please complete by Sunday 15 February.Only Clubs who have submitted this Club Affiliation Form will be able to commence registering through Play Football on the registration opening dates
Registration Package Set Up/Registration Windows	<ul style="list-style-type: none">Registration Packages 23rd Jan 2026 in Play Football. Packages must be approved by CF prior to any Clubs commencing registrations to ensure they are set up correctly
Team Lists	<ul style="list-style-type: none">Clubs are required to send squad lists to CF (abigail.moss@capitalfootball.com.au) by 13th AprilClubs are required to have players mapped into Dribl prior to Friday 17th April 2026.Clubs are to update Capital Football when players are to be added/removed from team lists.
Age Exemptions	<ul style="list-style-type: none">Clubs are asked if they could please have all age exemptions requested through the 2026 SAP Age Exemption Form by Friday 10th April to ensure that all players are processed prior to the registration closure.
Trial Matches	<ul style="list-style-type: none">Clubs are required to complete the Trial Match Request Form for any inter club trial matches (i.e. trial matches that are against another club), played either against other CF clubs or other Member Federation clubs.The form should be completed by the home club, except where you are playing another Member Federation club (CF club must complete this form).This form must be submitted a minimum of seven (7) days prior to the trial match being held (please note this has been altered from previous seasons where it was five business days).
Pre-season Meeting	<ul style="list-style-type: none">The SAP pre-season meeting will be held in March, with the date TBC.We ask that where possible, all Clubs send one (1) representative per team. More information will become available in the new year.
Allocations Period	<ul style="list-style-type: none">Dates are currently awaiting confirmation from ACT Sportsgrounds. Once confirmed, this document will be updated and clubs will be notified accordingly. It is important that all clubs are aware that an allocation does not constitute an actual ground, it is simply a reservation. Hirers are required to submit an online booking to secure their allocations. The booking system opening date for Winter 2026 is yet to be confirmed.
