### COACHING QUALIFICATIONS:

For the 2026 season, Capital Football Clubs participating in the Premier Leagues are required to meet the following minimum requirements for their coaching teams.

**PLEASE NOTE** - during the season, Capital Football may ask coaches / TD's etc. to provide evidence of their license / accreditation to prove that they are able to be in their relevant position.

### AMATEUR COMPETITIONS:

The 2026 CF NPL competitions have been set as amateur only competitions, the same that was set in the previous season. Given that the 2026 season is deemed amateur, clubs will not be able to sign players using the FFA Prescribed Form NRR05 – Professional Player Contract.

## EXEMPTIONS:

The process of exemptions and biological maturation testing has been communicated with all NPL Clubs for the 2026 season and is available on our website.

The testing of biological maturation can commence from the 1<sup>st</sup> of January 2026 for the 2026 season, testing conducted in 2025 will not be valid for the 2026 season and all testing is to be conducted at Southside Physiotherapist.

For Biological Maturations and all other exemptions requests, in line with the NPL Regulations, the JotForm will be provided to clubs at the beginning of 2026.

## PHYSIOTHERAPIST AND SPORTS TRAINER:

It is a requirement that at all NPL matches a qualified Physiotherapist for NPL Men's and Women's and a qualified Sports Trainer for NPL Boys and Girls.

The Physio and Sports Trainers are also required to be listed on the match sheet, failure to do so may result in offending Club being sanctioned.

## PLAYING STRIPS

The NPL logo is referred to as the Competition logo and is required to be placed on the Club's primary and alternate strip, at a minimum in the following competitions:

- NPL Women's – First Grade and Reserve Grade;
- NPL Men's – First Grade and U23's;
- NPL Boys – U14, U15, U16, U18
- NPL Girls - U14, U16, U18

Clubs are not permitted to place the NPL Competition logo on the playing strip of the competitions other than NPL age grades.

The Competition logo must appear on the right chest when worn. Should the manufacturer logo also appear on the right chest, the Competition Logo shall be placed directly above the manufacturer logo.

Where possible, the Clubs are to use the NPL logo on their playing kits, however where the Competition logo is being sublimated, Club's need to ensure they use the appropriate colour to ensure the logo doesn't get lost.
